

### Parent School Association Sponsored ALL-SCHOOL FIELD TRIP TO RELLEKE FARM

Holy Family students will have an All-School Field Trip on Monday, Oct. 7, 2019, to Relleke Farm in Pontoon Beach. Buses will leave school at 9:00 a.m., depart Relleke Farm about 12:30 p.m., and arrive back at school about 1:00 p.m. Activities will include: a hay ride through a pumpkin patch, the straw pyramid slide, goat feeding, and the jungle maze. Each student may paint a small pumpkin to take home.

Lunch will be served at Relleke Farm for \$3.00, which is to be submitted to the school prior to the trip (see attached form). Lunch will include a hot dog, chips, and water or a Capri Sun drink. Students may bring a cold lunch, but space is limited on the bus and students must take their lunch along with them during the outing as they will not be allowed to return to the bus.

No child will be allowed to bring extra money to spend on the trip. Chaperones are not allowed to purchase food or items for students on the trip.

The field trip requires many parent volunteer chaperones, need based on grade level. Chaperones **must** ride the bus with the students and cannot take younger preschool children on the field trip. Chaperones cannot take their private cars. If we do not have enough parents, the trip will be canceled. To attend as a chaperone, adults must have a clear background check and must have completed a Protecting God's Children class.
